私家小巴批准申請書(學校私家小巴服務除外) 填表須知

甲 發牌條件

- (1) 署長可拒絕接受不是法人團體或是 18 歲以下自然人的車主所提出的申請;
- (2) 私家小巴決不可以收受報酬方式接載乘客,除非該車輛的牌照註明其用途為接載一教育機構的學生、教師或員工、傷殘人士或受僱協助 傷殘人士的員工。
- (3) 私家小巴批准只發給能充份證明其需要屬實,而其他交通設施又不足以應付載運需求的申請人。
- (4) 私家小巴只能用作接載運輸署署長批准接載的乘客,不能供其他用途。
- (5) 私家小巴必須先經運輸署署長批准方可過戶。
- (6) 在換領車輛牌照前,一輛私家小巴必須先經運輸署檢驗及格。該車輛的批准在期滿後不一定可以獲准續期。該車必須符合運輸署署長認 為適當的條件,方可續期。
- (7) 私家小巴亦須遵守批准該車輛的信件所列明的其他條件。

乙 填寫表格

- (1) 表格的一切有關項目,必須用正楷填寫,不適用的項目必須註明"不適用"。「己欄」的聲明必須由申請人簽署。(申請者如屬有限公司/法團,該聲明必須由在表格的「甲欄」第8項獲授權的人士簽署。)
- (2) 本署主要根據申請人所提供的資料及證明文件去審核申請書。若資料不全或有漏報,申請可能不獲考慮或申請人可能被約見澄清疑點。
- (3) 填表時,若有任何塗改,必須由申請人簽署作實(及蓋章,如適用)。

丙 遞交申請書

申請書填妥後,必須親自遞交或用掛號郵遞寄往香港金鐘道 95 號統一中心 3 樓運輸署公共車輛分組。申請書必須連同下文「己」項列明的所有有關文件一起遞交,本署將不退還已遞交的申請書及證明文件。

丁 更改資料

申請書內所填報的資料如有任何更改,申請人必須立即通知運輸署署長。

戊 警告

- (1) 根據防止賄賂條例(香港法例第二〇一章),任何人士,如向公務員提供利益,乃屬違法。如有公務員,或聲稱為公務員的代理人向申請人索取利益,申請人應立即向廉政公署舉報。
- (2) 申請人如為求獲發私家小巴批准而故意提供失實資料,其申請即告無效。此外:根據道路交通條例(香港法例第三七四章)第一百一十 一條(第三款),其本人可能因此而被檢控,一經定罪,可被判罰款五千元及監禁六個月。

己 證明文件

下列文件(除非另有註明,否則須為簽署作實副本)應連同申請表格一起送交本署:

- (1) (a) 若申請人是個別的私人經營者
 - (i) 香港身份證;(經郵遞申請所遞交的身份證影印副本,本署會於處理申請後銷毀)
 - (ii) 有效的商業登記證。

(若商業登記證的商號名稱與申請人的姓名不同,需要遞交一份由税務局簽署作實的表格一(甲)或表格一(丙)的商業登記申請 書。)

- (b) 若申請人是一有限公司
 - (i) 公司註冊證;
 - (ii) 公司組織章程大綱及細則(正本/簽署作實副本);
 - (iii) 有效的商業登記證。
- (c) 若申請人是一社會服務團體或其他機構
 - (i) 顯示該機構是一法團的證明文件;
 - (ii) 顯示該機構的組織、宗旨等的證明文件;
 - (iii) 由税務局發出的免税信件(如適用)。
- (2) 擬申請過戶或轉類車輛的車輛登記文件正頁及背頁(如適用)。
- (3) 若申請人透過車輛過戶取得擬使用的車輛,須同時遞交由登記車主所寫同意該車過戶予申請人及確定是否需要申請換車的信件正本(若該車的登記車主並未分別遞交該信件)。
- (4) 其他於上述未提及而有關連的證明文件及資料。

APPLICATION FOR APPROVAL FOR PRIVATE LIGHT BUS (EXCEPT SCHOOL PRIVATE LIGHT BUS SERVICE) NOTES FOR ATTENTION

A. CONDITIONS OF ISSUE

- The Commissioner may refuse to accept an application from an owner who is not a body corporate or is a natural person under the age of 18 years.
- (2) A private light bus must not be used to carry passengers for hire or reward unless it is licensed to carry students, teachers or employees of an educational institution or disabled persons and persons assisting them.
- (3) An application for approval for private light bus is approved only where it is satisfactorily shown that the need is genuine and the demand cannot be satisfactorily met by other transport facilities.
- (4) A private light bus must exclusively be used for the conveyance of passengers approved by the Commissioner for Transport.
- (5) Ownership of a private light bus cannot be transferred without the prior approval of the Commissioner for Transport.
- (6) Prior to renewal of the vehicle licence, a private light bus must pass a vehicle examination conducted by the Transport Department. Approval for private light bus for further periods is not automatic and may be approved subject to such conditions as considered appropriate from time to time by the Commissioner for Transport.
- (7) A private light bus is also subject to any other conditions as stipulated in the letter approving the private light bus.

B. COMPLETION OF FORMS

- (1) All relevant items of this form should be completed in <u>BLOCK LETTERS</u>. Items that are not applicable should be marked "N.A.". The declaration in Part F must be signed by the applicant. (In the case of a limited company/body corporate, the declaration should be signed by an authorized person stated in item 8 of Part A.)
- (2) Assessment of an application depends largely on the details and supporting documents provided. Incomplete or insufficient information may render the application unacceptable for consideration or may result in the applicant being required to attend interviews for clarification.
- (3) Any alteration made to the completed application form must be initialled by the applicant (and affixed with chop, where applicable).

C. SUBMISSION OF APPLICATIONS

All completed applications should be submitted either in person or by registered post to the Public Vehicles Unit of the Transport Department at 3/F., United Centre, 95 Queensway, Hong Kong. The application form must be accompanied by all relevant documents as indicated in Part F below. Application form and supporting documents submitted are not returnable.

D. AMENDMENT

The Commissioner for Transport should be notified of any change in particulars of the application immediately.

E. WARNING

- (1) Applicants are reminded that it is an offence under the Prevention of Bribery Ordinance (Chapter 201) for any person to offer an advantage to a Government Servant. In the case of a Government Servant or any person representing to be his agent seeking or soliciting advantage from an applicant, he should immediately report to the Independent Commission Against Corruption.
- (2) Applicants are also reminded that if they knowingly make any statement which is false in a material particular for the purpose of obtaining the grant of approval for a private light bus, they will not only render their applications null and void but will also render themselves liable to prosecution under section 111(3) of the Road Traffic Ordinance (Chapter 374) and on conviction to a fine of \$5,000 and to imprisonment for 6 months.

F. SUPPORTING DOCUMENTS

The following documents (certified true copy, unless otherwise specified) should be forwarded at the time of submission of the application form:—

- (1) (a) where the applicant is an individual person
 - (i) Hong Kong Identity Card; (the copy of the identity card attached with the application submitted by registered post will be destroyed after processing the application)
 - (ii) Valid Business Registration Certificate.
 - (If the name of business of the Business Registration Certificate differs from the name of applicant, a certified true copy of business registration application (Form 1(a) or 1(c)) obtained from the Inland Revenue Department is required.)
 - (b) where the applicant is a limited company
 - (i) Certificate of Incorporation;
 - (ii) Memorandum and Articles of Association (original/certified true copy);
 - (iii) Valid Business Registration Certificate.
 - (c) where the applicant is a social service agency or other organization
 - (i) Documents showing that the organization is a corporate body;
 - (ii) Official documents conferring the purpose and aim of the organization;
 - (iii) Tax exemption letter issued by the Inland Revenue Department, if applicable.
- (2) Vehicle registration document (both the front and reverse sides) in respect of the vehicle(s) to be transferred/reclassified, if applicable.
- (3) For vehicle to be acquired by transfer of ownership, original copy of letter from the registered owner agreeing to the transfer and confirming whether he/she will apply for a replacement vehicle or not (if such letter has not been separately submitted by the registered owner).
- (4) Other relevant documents/information in support of the application not mentioned above.
