

## **TRANSPORT DEPARTMENT NOTICE**

### **Temporary Traffic and Transport Arrangements in Central District**

Notice is hereby given that to facilitate construction works, the following temporary traffic and transport arrangements will be implemented in Central District during the periods specified as below:

#### **From 1.00 am to 6.00 am daily on Mondays to Fridays between 18 June 2024 and 31 July 2024 (except Public Holidays)**

##### **A. Road Closure**

The following road sections and traffic lanes will be temporarily closed:

- (a) The slip road leading from Murray Road southbound to Cotton Tree Drive northbound; and
- (b) The left lane of Murray Road between Lambeth Walk and Garden Road.

##### **B. Traffic Diversion**

Affected vehicles leading from Murray Road to Cotton Tree Drive northbound will be diverted via Queensway eastbound, Tamar Street northbound, Harcourt Road westbound, Cotton Tree Drive southbound, U-turn and Cotton Tree Drive northbound.

#### **From 1.00 am to 6.00 am daily on 27, 28 June, 4, 5, 9, 18, 19, 23, 24, 25, 26 and 27 July 2024**

##### **A. Road Closure**

The following road sections and traffic lanes will be temporarily closed:

- (a) The slip road from Harcourt Road westbound heading to Murray Road;
- (b) The section of Murray Road between Lambeth Walk and Queensway;
- (c) The right lane of Chater Road eastbound near Murray Road; and
- (d) The left lane of Lambeth Walk near Murray Road.

##### **B. Traffic Diversion**

- (a) Affected vehicles on Harcourt Road westbound heading to Cotton Tree Drive northbound or Queensway eastbound will be diverted via Connaught Road westbound, U-turn, Connaught Road Central eastbound and Cotton Tree Drive southbound; and
- (b) Affected vehicles on Chater Road eastbound or Lambeth Walk heading to Cotton Tree Drive northbound or Queensway eastbound will be diverted via Jackson Road northbound, Connaught Road Central westbound, U-turn, Connaught Road Central eastbound and Cotton Tree Drive southbound.

##### **C. Temporary Bus Service Arrangements**

The following temporary bus service arrangements will be implemented:
