#### **I. ROUTEING**

COURTYARD BY MARRIOTT HONG KONG SHA TIN to AIRPORT: via On Ping Street, On Sum Street, Tai Chung Kiu Road, Fo Tan Road, Tai Po Road (Sha Tin), Shing Mun Tunnel Road, Shing Mun Tunnel, Cheung Pei Shan Road, Tsuen Kam Interchange, Texaco Road, flyover, Texaco Road, Tsing Tsuen Road, Tsing Yi North Coastal Road, Tsing Ma Bridge, Lantau Link, Kap Shui Mun Bridge, North Lantau Highway, Airport Road, Cheong Hong Road and departure kerb at Airport Terminal 1.

AIRPORT to COURTYARD BY MARRIOTT HONG KONG SHA TIN: via Airport Coach Station, Cheong Shun Road, Cheong Lin Road, Airport South Interchange, Airport Road, North Lantau Highway, Lantau Link, Tsing Ma Bridge, Tsing Yi North Coastal Road, Tsing Tsuen Road, Texaco Road, flyover, Texaco Road, Cheung Pei Shan Road, Shing Mun Tunnel, Tai Po Road (Sha Tin), Fo Tan Road, Tai Chung Kiu Road, On Lai Street and On Ping Street.

#### **II. STOPPING POINT**

- Courtyard by Marriott Hong Kong Sha Tin (within the private premise of Courtyard by Marriott Hong Kong Sha Tin)
- Airport Terminal 1, departure kerb (drop-off only)
- Airport Coach Station (pick-up only)

*[a Travel Industry Vehicle Permit from the service contractor of the Airport Authority Hong Kong is required for access to Terminal 1 Coach Station]*

Prior approval has to be obtained from the management offices of Airport Authority Hong Kong and Courtyard by Marriott Hong Kong Sha Tin for entering.
