

# Important Notice

## Verification of E-contact Means

In accordance with the law, applicants must provide either a Hong Kong mobile phone number through which they can be contacted by an SMS message or an email address through which they can be contacted by an electronic mail as the e-contact means when submitting driving or vehicle licensing applications. The e-contact means must be verified by one time password through the online licensing services or designated online platform of the Transport Department within three months before submitting an application. ## Requirement of Address Proof

The original or a copy of the proof of address issued within the last three months **has to** be produced when submitting a licensing application. In accordance with the relevant legislation, the Transport Department may suspend processing the application in the absence of address proof. [[Please refer to the list of acceptable proof of address](#)]

## Change of Address or E-contact Means

According to the law, driving licence holders or registered vehicle owners have to notify the Transport Department within 72 hours of their change of address or e-contact means. Any person without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1. You may notify the Transport Department of change in address with your proof of new address (if applicable) through [GovHK](#), by submitting [the specified form](#) ("Change of Personal Particulars or Vehicle Particulars") or in writing.

## Mail Items with Insufficient Postage

For proper delivery of your mail items to this department, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure your mail items bear sufficient postage before posting [[Please note the latest details about postage rates by Hongkong Post](#)]. This department will not receive any underpaid mail items. Any underpaid mail items will be handled by the Hongkong Post, which actions including but not limited to levying a surcharge on the sender for mail item that bears a sender's address.

## Submission of Identity Document

For application submitted by post/ via drop-in box, please **do not** submit the **original** identity document.

## Arrangement of Counter Service at Licensing Offices

If you wish to submit your application in person/by agent over the counter at licensing offices, you may make an appointment for counter service in advance either online or by phone (for details, please refer to [GovHK's website](#)) to reduce waiting time. Applicants without valid appointment are required to obtain a same-day queue ticket on-site before using the counter services (for details on the queue ticketing system and daily ticket quotas, please refer to our [website](#)).

- (3) 殘疾人士如欲申請駕駛執照，請聯絡本署駕駛事務組(電話：2713 7262) 安排駕駛能力評估，若你能通過上述的評估或檢查，運輸署署長將向你發出批准信，參加駕駛考試及申領合適的駕駛執照。
- (4) 如果你在日後患上任何疾病或身體傷殘可令你在駕駛時對公眾構成危險，你須立即以書面向運輸署署長報告。
- (5) 如果申請由代理人遞交，代理人必須同時出示其本人的身分證明文件正本，以作記錄。
- (6) 若有法庭命令指示運輸署署長拒絕向你簽發駕駛執照，運輸署署長無權向你簽發有關牌照。
- (7) 有關申領駕駛執照，如申請人曾以支票支付未繳付的交通罰款，運輸署會在以支票付款日七個工作天後，才辦理有關申請。
- (8) 為確保郵件能妥善送達本署，並免卻不必要的派遞延誤或失誤，請切記投寄郵件前支付足額郵資[請參閱香港郵政有關郵費的最新詳情]。本署不會接收郵資不足的郵件。若郵件郵資不足，有關郵件將由香港郵政處理，當中包括但不限於向有註明回郵地址的寄件人徵收附加費。
- (9) 運輸署署長在處理牌照申請時，可要求申請人出示其現時地址的證明，以及在申請人出示該等證明之前，暫停處理該申請。因此，請申請人士帶同現時地址的證明，並在牌照事務處人員要求下，出示該地址證明。
- (10) 在完成辦理你的申請後，你所提交的證明文件副本將會被銷毀。

- (14) 如欲申請新領、續領或加領商用車輛之正式駕駛執照，你必須是有效的香港永久性居民身份證持有人；或是香港永久性居民身份證以外的香港身份證持有人，並且不受任何逗留條件所規限(但《入境條例》(第 115 章) 第 2(1) 條所界定的逗留期限除外)。

強制修習駕駛改進課程

- (15) 如你曾被要求修習和完成強制駕駛改進課程而你並未遵從該要求完成有關課程，運輸署署長不得向你發出或重新發出駕駛執照，或將駕駛執照續期。

的士、公共小巴及公共巴士司機前課程

- (16) 所有申領的士、公共小巴及公共巴士正式駕駛執照的人士，須通過由本署舉辦的相關駕駛考試，及在遞交申請前完成經本署核准的相關前課程並獲取有關的職前訓練學校所發出的有效課程證書，才可申領相關的正式駕駛執照。課程證書內所指定的完成課程日期須為申請相關正式駕駛執照日期之前的一年內。有關職前課程的詳情，請瀏覽運輸署網站：[www.td.gov.hk](http://www.td.gov.hk)。

更改個人資料

- (17) 如任何駕駛執照持有人/登記車主曾向運輸署署長提供其姓名、地址、電子聯絡方式或身分證明文件有所改變，他/她須在改變出現後 72 小時內以書面通知運輸署署長，並需提交有關改變的證明。任何人無合理辯解而違反此規定，即屬犯罪，可處第 1 級罰款。如屬姓名的改變或身分證明文件的改變，駕駛執照持有人/登記車主亦須將現時持有的駕駛執照、駕駛教師執照、車輛登記文件、車輛牌照及自訂登記號碼分配證明書的正本送交運輸署署長，以作修改。

- (19) 如欲向運輸署署長申請刪除在駕駛執照和駕駛教師執照內「須戴眼鏡或矯正視力的鏡片」的駕駛限制，申請人須遞交由註冊醫生或專業視光師發出的證明書(正本及副本)，並附上駕駛執照或駕駛教師執照正本(如持有)。
- (20) 如你於駕駛時須配戴助聽器，請你於遞交申請前先行聯絡運輸署駕駛事務組(電話：2713 7262)，以安排評估你的聽覺能力。

## General Information

- (1) E-Contact Means—Applicants must provide either a Hong Kong mobile phone number through which they can be contacted by an SMS message or an email address through which they can be contacted by an electronic mail as the e-contact means when submitting driving or vehicle licensing applications. The e-contact means must be verified through the website of the Transport Department within three months before submitting an application, otherwise the processing of the application may be suspended. For details, please refer to the website of the Transport Department ([www.td.gov.hk](http://www.td.gov.hk)). If both Hong Kong mobile phone number and email address are provided, the Hong Kong mobile phone number would be given priority as the means for issuing electronic notification. Please refer to the “Notes About Your Personal Data” for the purposes of collecting e-contact means and the class of transferees. In particular, the Transport Department, Hong Kong Police Force, other Government departments, bureaux and Toll Service Provider may issue electronic notification to you through the e-contact means provided by you, either by SMS or email, as and when necessary. For instance, an Electronic Fixed Penalty Notice and Electronic Demand Notice may be issued by the Hong Kong Police Force to you through the e-contact means if you commit a traffic contravention under the Fixed Penalty (Traffic Contraventions) Ordinance (Cap. 237) or traffic offence under the Fixed Penalty (Criminal Proceedings) Ordinance (Cap. 240); a toll payment notification may be issued by the Toll Service Provider to you through the e-contact means when the toll cannot be successfully paid by automated payment means where your vehicle passes through a tunnel implemented with Free-Flow Tolling System. Please note that non-counter application takes about 10 working days for processing. The relevant systems would update your record according to the information provided in this form within one calendar day upon complete processing of the application.

- (3) People with disabilities who wish to apply for a driving licence may contact Driving Services Section of Transport Department (Tel.: 2713 7262) for the arrangement of an appointment for driving ability assessment. Subject to the result of the assessment, you will be given an approval letter for applying for driving test and appropriate licence from the Commissioner for Transport.
- (4) If you subsequently suffer from any disease or physical disability which may cause the driving by you to be a source of danger to the public, you should report in writing to the Commissioner for Transport immediately.
- (5) If the application is submitted by an agent, the agent is also required to produce his/her own original identity document for record purpose.
- (6) The Commissioner for Transport is not empowered to issue any driving licence to you if there are any outstanding court orders directing the Commissioner for Transport to refuse to issue the licence to you.
- (7) If applicant has used cheque to settle payment of outstanding traffic fines, application for issue/renewal of driving licence would only be processed after 7 working days from the date of cheque payment.
- (8) For proper delivery of your mail items to this department, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure your mail items bear sufficient postage before posting [Please note the latest details about postage rates by Hongkong Post]. This department will not receive any underpaid mail items. Any underpaid mail items will be handled by the Hongkong Post., which actions including but not limited to levying a surcharge on the sender for mail item that bears a sender’s address.
- (9) The Commissioner for Transport may, in processing licensing application, require the applicant to **produce proof of his/her present address**, and may suspend the processing of the application until the production of such proof. Applicants please bring along your proof of present address (issued not more than 3 months from now) for presentation as and when requested by officers of licensing offices.
- (10) Copy of your submitted supporting document(s) will be destroyed after processing your application.

### Only Applicable to Full Driving Licence Applicant (Item 11-14)

- (11) You can apply for full driving licence for the respective vehicle class(es) within 3 years from the date of completion of the relevant probationary driving period for the relevant vehicle class; otherwise, you will have to re-apply for a learner’s driving licence, pass the driving test of the relevant vehicle class(es) and complete the probationary driving period again before you can apply for a full driving licence for the respective vehicle class(es).
- (12) If you have committed a specified offence during the probationary driving period but have not been convicted during the probationary driving period, you will still be eligible for applying a full driving licence. However, the full driving licence that you have obtained shall be **cancelled** and the licence fee paid shall not be refunded if you are convicted of the offence at a later date. Therefore, in submitting your application for full driving licence, your attention is drawn to whether you have committed a specified offence during your probationary driving period and whether you have fulfilled the requirements for obtaining a full driving licence, in order to avoid any subsequent cancellation of your full driving licence upon conviction of the offence.
- (13) If your full driving licence has been cancelled upon conviction of a “minor” offence committed during the probationary driving period, you must apply for reissue of probationary driving licence within 3 years from the cancellation date of your full driving licence. You will be eligible for applying for a full driving licence after satisfactory completion of the extended probationary driving period.
- (14) If you apply for a full driving licence with commercial vehicle class(es), you must be the holder of a Hong Kong Permanent Identity Card; or the holder of a Hong Kong Identity Card (other than a Hong Kong Permanent Identity Card) and are not subject to any condition of stay (other than a limit of stay as defined in section 2(1) of the Immigration Ordinance (Cap.115)).

### Mandatory Attendance of Driving Improvement Course

- (15) If you have been required to attend and complete mandatory attendance of driving improvement course(s) and you have not complied with the requirement, the Commissioner for Transport shall not issue, reissue or renew a driving licence to you.

### Pre-service Courses for Taxi, Public Light Bus and Public Bus

- (16) All applicants for full driving licence for Taxi, Public Light Bus and Public Bus shall pass the relevant driving test administered by this department, complete the relevant Pre-service Course as approved by this department and obtain the valid course certificate issued by the pre-service training school concerned before submitting their applications. The date of completion of the course specified in the course certificate shall fall within one year preceding the date of application for the relevant full driving licence. For details of the Pre-service Courses, please visit Transport Department’s website: [www.td.gov.hk](http://www.td.gov.hk).

### Change of Personal Particulars

- (17) If a change occurs in the **name, address, e-contact means or identity document** of a driving licence holder/registered vehicle owner previously provided to the Commissioner for Transport, he or she shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable to a fine at level 1. For cases of change of name or change of identity document, he or she shall also deliver to the Commissioner for Transport the following documents for amendment, including original copy of the existing driving licence, driving instructor’s licence, vehicle registration document, vehicle licence and Certificate of Allocation of Personalized Registration Mark, if applicable.
- (18) If the address and/or e-contact means provided in this application form is/are different from the vehicle/driving licence records of the applicant under the same identity document no./ Certificate of Incorporation no./Company Registration no. held by this Department, we will update all relevant information in our records accordingly, including the e-contact means provided to the Commissioner for Transport in accordance with the Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374E) and the Road Traffic (Driving Licences) Regulations (Cap. 374B) as well as the address contained in the “Record of driving licences and permits” stipulated under regulation 39 of Road Traffic (Driving Licences) Regulations (Cap. 374B) and “Register of vehicles” stipulated under regulation 4 of Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374E).
- (19) If you wish to apply to the Commissioner for Transport for deletion of the driving restriction “To wear glasses or corrective lenses”, please provide **original and copy** of medical certification or certificate, issued by Registered Medical Practitioner/Registered Optometrist and your **original** driving licence or your **original** driving instructor’s licence (if applicable).
- (20) **If you need to wear hearing aids when driving, please first approach Driving Services Section of Transport Department (Tel: 2713 7262) for arranging hearing ability assessment before submission of your application.**
