- (i) management of the Tunnel (including taking enforcement actions under the applicable ordinances and regulations);
- (ii) collection of tolls, approved fees and charges;
- (iii) control and regulation of traffic;
- (iv) patrolling and security;
- (v) handling incidents occurred within the Tunnel Area;
- (vi) recovery and removal of broken down vehicles; and
- (vii) cleansing of Tunnel;
- (b) operation and maintenance of the electrical and mechanical equipment and electronic systems of the Tunnel, including:
 - (i) power supply system;
 - (ii) lighting system;
 - (iii) ventilation system;
 - (iv) toll collection system; and
 - (v) traffic control and surveillance system;
- (c) operation and maintenance of automatic toll collection system; and
- (d) selection and appointment of advertising agent(s) for displaying advertisements at approved locations within the tunnel area.

The duration of the agreement shall be six (6) years commencing on 11 July 2021 or on a date the Government of the Hong Kong Special Administrative Region shall specify by notice.
