<b>Description:</b>	The service involves enhancing the infrastructure and application of the Vehicles and Drivers Licensing Integrated Data (VALID) V System and replace its ageing database system and architecture, with a view to meeting operational needs and improving system functionality and performance. It is anticipated that the service will begin in Q3 2025, with an implementation period of approximately 42 months, followed by a maintenance period of 10 years.

<b>Submission of Tenders:</b>	<p>For paper-based tendering, tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the Lobby of the Public Entrance on the Ground Floor of East Wing of Central Government Offices, 2 Tim Mei Avenue, Tamar. Tenders must be deposited in the tender box as specified in this tender notice (“Specified Tender Box”) before the tender closing time. For electronic tendering, transmission of a tender through the e-TS shall be successfully completed in accordance with the requirement of the e-TS before the tender closing time.</p> <p><b>Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.</b></p> <p>If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or “extreme conditions” announced by the Government is/are in force at any time between 9:00 a.m. and 12:00 noon on 24 January 2025 (Hong Kong time), the tender closing time will be postponed to 12:00 noon (Hong Kong time) on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the “extreme conditions” announced by the Government has/have ceased to be in force.</p> <p>In case of blockage of the public access to the location of the Specified Tender Box at any time between 9:00 a.m. and 12:00 noon on 24 January 2025 (Hong Kong time), the Government will announce the extension of the tender closing time until further notice.
