Description : The works mainly comprise:

- (i) Relocation of the SCATS equipment, mainly comprises of regional computers and telecommunication devices at Kowloon Government Offices to West Kowloon Government Offices;
- (ii) Redirection of all the telecommunication links including the Cat 2 private circuits for operations of SCATS at Kowloon Government Offices to West Kowloon Government Offices;
- (iii) Upgrading of SCATS from version 6.6 to the latest version; &
- (iv) Provision of a unified graphical user interface for SCATS.

The works are scheduled to commence in August 2019 and for completion in about 16 months.

An announcement of the change will be made through the radio.

- b. Open tendering is adopted. All interested contractors who also meet the following requirement are invited to tender:

The tenderer, or the major shareholder/ lead participant in case of a joint venture tenderer has completed at least one contract of area traffic control system and/ or traffic control & surveillance system of value not less than **HK\$6.6 million**, in or outside Hong Kong, within the **past 10 years** from the original date set for the close of tender.
