## 核實「電子聯絡方式」

根據法例，申請人遞交各項駕駛執照或車輛牌照服務申請時，必須提供一個可藉短訊方式聯絡申請人的香港流動電話號碼或可藉電子郵件方式聯絡申請人的電郵地址，作為電子聯絡方式。有關電子聯絡方式必須於遞交申請前三個月內經運輸署網上牌照服務或指定網上平台，以一次性密碼核實，詳情請參閱[運輸署網頁](#)，或掃描此二維碼。

## 在車輛登記文件簽署及蓋印規定

車輛登記文件(以下簡稱為「牌簿」)上**必須**載有登記車主簽署，而當登記車主遞交有關的牌照申請時，申請表格上的簽署必須與牌簿上的簽署相符；如以公司/機構為登記車主，牌簿**必須載有**由該公司/機構所指定獲授權人士的簽署並加蓋該公司/機構的印章，而申請表格上的印章與牌簿上的印章**必須完全相同**，否則運輸署將**不會**處理有關的牌照申請。

## 地址證明要求

於遞交牌照服務申請時，**必須**連同最近三個月內發出的地址證明文件正本或副本，否則運輸署可以根據有關法例暫停處理有關申請。[\[請參閱可接納的地址證明\]](#)

## 更改地址或電子聯絡方式

根據法例，駕駛執照持有人或登記車主的地址或電子聯絡方式如有改變，須在72小時內通知運輸署。任何人無合理辯解而違反此規定，即屬犯罪，一經定罪，可處第1級罰款。你可透過[政府一站通](#)、遞交**指明的表格**（「更改個人資料或車輛資料通知書」）或以書面方式，連同新地址的證明文件（如適用）通知運輸署有關地址的更改。

## 提交身分證明文件

如以郵寄方式或經投遞箱遞交申請，**請勿**提交身分證明文件正本。

## 郵件貼上足夠郵資

為確保郵件能妥善送達本署，並免卻不必要的派遞延誤或失誤，請切記投寄郵件前支付足額郵資 [\[請參閱香港郵政有關郵費的最新詳情\]](#)。本署不會接收郵資不足的郵件。若郵件郵資不足，有關郵件將由香港郵政處理，當中包括但不限於向有註明回郵地址的寄件人徵收附加費。

申請人可選擇把已填妥的申請表格及所需文件，經電郵 ([hklo\\_reg@td.gov.hk](mailto:hklo_reg@td.gov.hk)) 提供予牌照事務處作初步審閱。在一般情況下，本署會在10個工作天內以電郵形式作出回覆，告知申請人初步審閱的結果；並建議申請人**按照申請表格內列明的方式**將申請表格正本連同所需文件及應繳費用正式遞交至牌照事務處，以作出申請。透過電郵遞交的申請，本署只會作初步審閱，本署會在收到申請表格正本及所需文件後才正式處理及批核該申請。

# 車輛登記及牌照申請表

## 注意事項

### (一) 遞交申請表的地點及所需文件

申請表填妥後，可親自或由代理人交回香港金鐘道 95 號統一中心 3 樓運輸署香港牌照事務處（電話：2804 2637）。申請表必須連同下列文件一併遞交（如果申請由代理人遞交，代理人必須出示其本人的身分證明文件，以作記錄）：—

- 凡車輛屬私人所有，請出示香港身份證，非香港居民，則出示護照（注意：私人車主在登記時必須年滿十八歲）；如車輛屬公司擁有，就該出示公司註冊證書／非香港公司註冊證明書／公司更改名稱證書／註冊非香港公司變更名稱註冊證明書（商業登記證不會被接納）；
- 有效的第三者保險單或臨時保險單的正本或副本；
- 商業登記證，如登記車輛為的士、私家或公共小巴、私家或公共巴士；
- 車輛製造商或分銷商的發票或付款收據；
- 有關車輛的正式買賣合約或購貨訂單；
- 由香港海關簽發的汽車暫定稅值通知書及／或其他可能需要的有關車輛課稅證明文件；
- 經香港海關核准的公布零售價目表（如適用）；
- 由運輸署簽發的車輛類型核准證明書或檢驗汽車機械合格證書；
- 保留車輛登記號碼證明書，或該登記號碼的拍賣款項收據及發售備忘錄，或登記號碼的分配通知信（如適用）；
- （須進行首次登記前檢驗的車輛適用）經車輛安全及標準部在進行車輛首次登記前檢驗時所檢視的文件。如車輛曾在香港以外地區登記，申請人／註冊分銷商須出示由外地獲授權機構發出的車輛登記簿／登記文件或取消車輛登記證明。如車輛未曾在香港以外地區登記，申請人／註冊分銷商須出示 (i) 由車輛出口地獲授權機構發出，說明車輛在當地並未登記的證明，(ii) 車輛是註冊分銷商／進口者直接從車輛製造商取得作銷售用途的證明文件，或 (iii) 由車輛進口者根據香港法例第 11 章《宣誓及聲明條例》作出的聲明，說明車輛未曾在香港以外地區登記。若上述文件以中、英文以外的文字寫成，則須連同由合資格人士翻譯的中文或英文譯本遞交；
- 現時地址的證明（住址／公司地址及通訊地址）正本或副本，而該地址證明需發出距今不超過三個月（包括水電煤或電訊公司收費單、銀行、保險公司、政府部門、本地大學、國際或本地註冊的慈善機構發出的文件）。所有可接納的地址證明載列於本署網站 ([http://www.td.gov.hk/tc/public\\_services/licences\\_and\\_permits/proof\\_of\\_address/index.html](http://www.td.gov.hk/tc/public_services/licences_and_permits/proof_of_address/index.html))。如有查詢，可致電 2804 2600；
- 其他運輸署署長認為有關的文件；以及
- 應繳的稅款、費用及／或交通意外傷亡者援助徵款（如以支票／銀行本票付款，請劃線支付「香港特別行政區政府」，並在支票／銀行本票背面寫上你的姓名，車輛登記號碼及日間聯絡電話）。

在完成辦理你的申請後，你所提交的證明文件副本將會被銷毀。

### (二) 車輛課稅

- (1) 登記的車輛如屬汽車（首次登記稅）條例（第 330 章）規定的應課稅車輛，車主必須填寫本表格「車輛課稅」部分。
- (2) 買車時的汽車售價／所付款總額數應包括買車時所有材料、工程的成本、配件及保證的價值，經紀／代理／手續費等，但不應包括首次登記稅。
- (3) 如果沒有公布的零售價目，應申報各項經香港海關評定的暫定稅值。
- (4) 在第 (ii) 項中申報的自選配件，指在該車輛供出售時不是安裝在該輛汽車上，但因額外付款而安裝在該輛汽車上。
- (5) 聲明一欄須由下列人士簽署：
  - (a) 註冊分銷商或其委託人；以及
  - (b) 申請首次登記車輛的人士，即買車者或進口車輛人士（如非註冊進口商）。

### (三) 第三者風險保險

任何人（包括登記車主及司機）在道路上使用汽車，有責任確保有關汽車已購備有一份有效的第三者風險保險單。假如有關人士違反此規定，即屬犯罪，可被處罰款 10,000 元及監禁 12 個月；而其持有或領取駕駛執照的資格亦會被取消（由 12 個月至 3 年不等）。運輸署署長可拒絕發出有關車輛牌照或取消該車輛牌照。

### (四) 以支票支付未繳付的交通罰款

有關車輛牌照的申請，如申請人曾以支票支付未繳付的交通罰款，運輸署會在以支票付款日七個工作天後，才辦理有關申請。

### (五) 法庭命令

若有法庭命令指示運輸署署長拒絕向你簽發車輛牌照，則運輸署署長無權向你簽發有關牌照。

### (六) 更改個人或車輛資料

- (1) 如任何駕駛執照持有人／登記車主曾向運輸署署長提供其姓名、地址、電子聯絡方式或身分證明文件有所改變，他／她須在改變出現後 72 小時內以書面通知運輸署署長，並須提交有關改變的證明。任何人無合理辯解而違反此規定，即屬犯罪，一經定罪，可處第 1 級罰款。如屬姓名的改變或身分證明文件的改變，他／她亦須將現時持有的駕駛執照、駕駛教師執照、車輛登記文件、車輛牌照及自訂登記號碼分配證明書的正本送交運輸署署長，以作修改；
- (2) 運輸署署長在處理牌照申請時，可要求申請人出示其現時地址的證明，以及可在申請人出示該等證明之前，暫停處理該申請。因此，請申請人士帶同其現時地址的證明，並在牌照事務處人員要求下，出示其地址證明；以及
- (3) 如你在此申請書內填報的地址及／或電子聯絡方式與本署以你的身分證明文件號碼／公司註冊證號碼／公司編號登記的車輛牌照或駕駛執照的記錄有所不同，本署會根據此申請書內填報的資料同時更改有關紀錄，包括按《道路交通（車輛登記及領牌）規例》（第 374E 章）和《道路交通（駕駛執照）規例》（第 374B 章）備存的「電子聯絡方式」，及載於《道路交通（駕駛執照）規例》（第 374B 章）第 39 條下訂明的「駕駛執照及許可證的紀錄」以及《道路交通（車輛登記及領牌）規例》（第 374E 章）第 4 條下訂明的「車輛登記冊」內的地址。
- (4) 如車輛登記文件及車輛牌照內記載的事項（例如顏色、引擎號碼等）有任何改變，登記車主須把已填妥的運輸署表格 TD559，連同表格內所註明的文件，將有關改變通知運輸署署長。如你的車輛牌照已遺失或損毀，登記車主可向運輸署遞交已填妥的運輸署表格 TD151 申請車輛牌照複本。登記車主須在車輛上展示新的車輛牌照並確保牌照有效，方可在道路上使用該車輛。

### (七) 電子聯絡方式

申請人遞交各項駕駛執照或車輛牌照服務申請時，必須提供一個可藉短訊方式聯絡申請人的香港流動電話號碼或藉電子郵件方式聯絡申請人的電郵地址，作為電子聯絡方式。有關電子聯絡方式必須於遞交申請前的三個月內經運輸署網頁核實，否則本署可暫停處理該申請，詳情請參閱運輸署網頁 ([www.td.gov.hk](http://www.td.gov.hk))。如你同時提供香港流動電話號碼及電郵地址，則優先以香港流動電話號碼作為電子聯絡方式。關於電子聯絡方式的收集目的和獲轉交資料的部門／人士，請參考「關於你個人資料的說明」。具體而言，運輸署、香港警務處、其他政府部門、決策局及隧道費服務商在有需要時可根據你所提供的電子聯絡方式，以手機短訊或電郵向你發出電子通知。舉例說，如你干犯《定額罰款（交通違例事項）條例》（第 237 章）下的交通違例事項或《定額罰款（刑事訴訟）條例》（第 240 章）下的交通罪行，香港警務處可透過電子聯絡方式向你發出電子定額罰款通知書及電子繳付定額罰款通知書；當你的車輛通過已實施不停車繳費系統的收費隧道時，若未能以自動繳款方式即時繳付有關隧道費，隧道費服務商可透過電子聯絡方式向你發出電子繳費通知。請注意，經非櫃位方式遞交的申請需時約十個工作天處理，相關系統將於完成處理申請後的一個曆日內按表格提供的資料作出記錄更新。

### (八) 使用「易通行」

車主需開立或登入現有的「易通行」戶口，並將車輛加入至其戶口，以確保隧道費能從其戶口中扣除。如車主在未有登記「易通行」戶口的情況下曾駛經政府收費隧道，請在每次使用隧道後的 14 個工作天內透過「易通行」網站或流動應用程式內選擇「補交隧道費（無易通行戶口）」繳付當時的隧道費。

**NOTES FOR ATTENTION**

**1. PLACE OF SUBMISSION AND REQUIRED DOCUMENTS**

All completed applications can be submitted either in person or by an agent to the **Transport Department Hong Kong Licensing Office at 3/F, United Centre, 95 Queensway, Hong Kong (Tel. 2804 2637)**. Each application must be accompanied by (if the application is submitted by an agent, the agent is required to produce his/her own original identity documents for record purpose):—

- your Hong Kong Identity Card or a passport for non-identity card holders in the case of a private owner (Note: A private owner must be aged 18 years or above); In the case of a company, the Certificate of Incorporation/Certificate of Registration of Non-Hong Kong Company/Certificate of Change of Name/Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company must be produced (Business Registration Certificate will not be accepted);
- Original or photocopy of valid Third Party Risks Insurance Policy or Cover Note;
- Business Registration Certificate for registration of a Taxi, Private or Public Light Bus, Private or Public Bus;
- invoice or payment receipt of vehicle manufacturer or car distributor;
- sales contract or purchase order of the vehicle concerned;
- Notification of Motor Vehicle Provisional Taxable Value issued by the Customs and Excise Department and/or other relevant documentary proof in connection with vehicle taxation which may be required;
- Published Retail Price List approved by the Customs & Excise Department, if applicable;
- Type Approval Certificate or Certificate of Roadworthiness issued by the Transport Department;
- Certificate of Retention of Registration Mark, or a receipt for payment of the auction price of the registration mark and memorandum of sale, or the notification letter of allocation of the registration mark, if applicable;
- (Applicable to vehicles which require pre-registration inspection) Documents inspected by the Vehicle Safety and Standards Division during the vehicle pre-registration inspection. If the vehicle has been registered outside Hong Kong, the applicant/registered distributor shall produce the vehicle log book/registration document or certification of vehicle de-registration issued by the overseas authorized organization. If the vehicle has never been registered outside Hong Kong, the applicant/registered distributor shall produce (i) certification issued by the authorized organization at the exporting place indicating that the vehicle has never been registered, (ii) supporting documents showing that the vehicle was directly acquired by the registered distributor/importer from the manufacturer for sale, or (iii) declaration made by the vehicle importer under the Oaths and Declarations Ordinance (Cap. 11) stating that the vehicle has never been registered outside Hong Kong. Where the above documents are in a language other than Chinese or English, a translation prepared by a qualified person is required;
- Original or photocopy of proof of present address (residential address/company address and correspondence address) which is issued not more than 3 months from now (includes utility or telecommunication bills, documents issued by banks, insurance companies, government departments, local universities, international charitable organizations or charitable organizations registered in Hong Kong). The full list of acceptable proof of address is available at this Department's website ([http://www.td.gov.hk/en/public\\_services/licences\\_and\\_permits/proof\\_of\\_address/index.html](http://www.td.gov.hk/en/public_services/licences_and_permits/proof_of_address/index.html)). For enquiries, please call 2804 2600;
- such other relevant documents as may be required by the Commissioner for Transport; and
- the appropriate tax, fee and/or Traffic Accident Victims Assistance Scheme Levy (if pay by cheque/ cashier order, please make it payable to either “**The Government of the Hong Kong Special Administrative Region**” or “**The Government of the HKSAR**” and crossed. Please write down your name, vehicle registration mark and daytime contact telephone number on the back of the cheque/ cashier order).

Copy of your submitted supporting document(s) will be destroyed after processing your application.

**2. VEHICLE TAXATION**

- (1) If the vehicle being registered is liable to tax in accordance with the provisions of the Motor Vehicles (First Registration Tax) Ordinance (Cap. 330), the information required in the part ‘VEHICLE TAXATION’ of this form must be given.
- (2) The selling price/full price paid for the purchase of the motor vehicle should include the cost of all materials and works; value of accessories and warranty; and brokerage/agency/handling fee etc. in the purchase of the motor vehicle and exclude First Registration Tax.
- (3) Provisional Taxable Value assessed for any of the items by the Customs & Excise Department should be declared if there is no Published Retail Price.
- (4) Optional accessories declared under Item (ii) refer to those which are not fitted to a standard motor vehicle at the time when the vehicle is offered for sales; but which may be fitted to the vehicle for an additional payment.
- (5) The declaration should be signed by:
  - (a) the registered distributor or a person authorized by the former; and
  - (b) the person applying for first registration, being either the purchaser of the motor vehicle or the importer of the vehicle where he is not a registered importer.

**3. THIRD PARTY RISKS INSURANCE POLICY**

Any person (including the registered vehicle owner and driver) has the responsibility of ensuring the presence of a valid third party risks insurance policy for the vehicle concerned whilst using it on roads. Person who contravenes such requirement commits an offence and is liable to a fine of \$10,000 and imprisonment for 12 months, and will also be disqualified from holding or obtaining a driving licence (for a period of 12 months to 3 years). The Commissioner for Transport may refuse to license the vehicle concerned or cancel the vehicle licence concerned.

**4. SETTLE OUTSTANDING TRAFFIC FINES BY CHEQUE**

If applicant has used cheque to settle payment of outstanding traffic fines, application for licensing a vehicle would only be processed after 7 working days from the date of cheque payment.

**5. OUTSTANDING COURT ORDERS**

The Commissioner for Transport is not empowered to issue any vehicle licence to you if there are any outstanding Court orders directing the Commissioner for Transport to refuse to issue the said licence to you.

**6. CHANGE OF PERSONAL OR VEHICLE PARTICULARS**

- (1) If a **change occurs in the name, address, e-contact means or identity document** of a driving licence holder/registered vehicle owner previously provided to the Commissioner for Transport, he or she shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of the change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1. For cases of change of name or change of identity document, he or she shall also deliver to the Commissioner for Transport the following documents for amendment, including original copy of the existing driving licence, driving instructor's licence, vehicle registration document, vehicle licence and Certificate of Allocation of Personalized Registration Mark, if applicable;
- (2) The Commissioner for Transport may, in processing licensing application, require the applicant to **produce proof of his/her present address** and may **suspend the processing of the application** until the production of such proof. Therefore, applicants please bring along proof of present address for presentation as and when requested by officers of licensing offices; and
- (3) If the address and/or e-contact means provided in this application form is/are different from the vehicle/driving licence records of the applicant under the same identity document no./Certificate of Incorporation no./Company Registration no. held by this Department, we will update all relevant information in our records accordingly, including the e-contact means provided to the Commissioner for Transport in accordance with the Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374E) and the Road Traffic (Driving Licences) Regulations (Cap. 374B) as well as the address contained in the “Record of driving licences and permits” stipulated under regulation 39 of Road Traffic (Driving Licences) Regulations (Cap. 374B) and “Register of vehicles” stipulated under regulation 4 of Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374E).
- (4) If there is change of any entry in the registration document and vehicle licence relating to the vehicle (e.g. colour, engine no. etc.), the registered vehicle owner must submit a duly completed Transport Department Form TD559 together with the required documents stated in the form to notify the Commissioner for Transport of such change. If the vehicle licence is lost or defaced, the registered owner may submit a duly completed Transport Department Form TD151 to the Transport Department to apply for a duplicate vehicle licence. The registered owner must display the new vehicle licence on the vehicle and ensure the licence is valid for using the vehicle on road.

**7. E-CONTACT MEANS**

Applicants must provide either a Hong Kong mobile phone number through which they can be contacted by an SMS message or an email address through which they can be contacted by an electronic mail as the e-contact means when submitting driving or vehicle licensing applications. The e-contact means must be verified through the website of the Transport Department within three months before submitting an application, otherwise **the processing of the application may be suspended**. For details, please refer to the website of the Transport Department ([www.td.gov.hk](http://www.td.gov.hk)). If both Hong Kong mobile phone number and email address are provided, the Hong Kong mobile phone number would be given priority as the means for issuing electronic notification. Please refer to the “Notes About Your Personal Data” for the purposes of collecting e-contact means and the class of transferees. In particular, the Transport Department, Hong Kong Police Force, other Government departments, bureaux and Toll Service Provider may issue electronic notification to you through the e-contact means provided by you, either by SMS or email, as and when necessary. For instance, an Electronic Fixed Penalty Notice and Electronic Demand Notice may be issued by the Hong Kong Police Force to you through the e-contact means if you commit a traffic contravention under the Fixed Penalty (Traffic Contraventions) Ordinance (Cap. 237) or traffic offence under the Fixed Penalty (Criminal Proceedings) Ordinance (Cap. 240); a toll payment notification may be issued by the Toll Service Provider to you through the e-contact means when the toll cannot be successfully paid by automated payment means where your vehicle passes through a tunnel implemented with Free-Flow Tolling System. Please note that non-counter application takes about 10 working days for processing. The relevant systems would update your record according to the information provided in this form within one calendar day upon complete processing of the application.

**8. USING HKeToll**

The vehicle owners shall sign up for or log into an HKeToll account and add the vehicle to that account to ensure toll fees are deducted from it. After using the Government tolled tunnels, the vehicle owners who have not yet signed up for an HKeToll account should visit the HKeToll website or mobile application by selecting “Pay Toll (without HKeToll Account)” for completing the toll payment within 14 business days after passing through the tolled tunnels each time.
