

#### 請注意 Please note:

Please read the "Guidance Notes for Application for Personalized Vehicle Registration Mark" before completing the application form (in BLOCK CAPITALS). All items must be completed, otherwise the application may not be processed. The Guidance Notes are available at the Licensing Offices of the Transport Department (TD) and can be downloaded from TD website at www.td.gov.hk.

No withdrawal of application will be allowed after submission. **Each applicant** may only submit **ONE application** in response to each invitation by the Commissioner for Transport. If one submits more than one application for an invitation, all applications he/she/the Limited Company submitted in response to that invitation will not be processed.

A personalized vehicle registration mark shall consist of letters and/or numerals the total of which shall not exceed 8. "I", "O" and "Q" are not allowed. Blank space is allowed in a personalized vehicle registration mark, but each blank space shall be taken as one letter or numeral for inclusion for the total, and there shall be not more than one blank space between any 2 letters and/or numerals. Please refer to the Road Traffic (Registration and Licensing of Vehicles) Regulations and the Guidance Notes for other basic combination requirements for personalized vehicle registration marks.

No alteration, addition, deletion to the personalized vehicle registration mark printed in Part A of the application form will be allowed after submission of application. If the arrangement in two rows is not provided, accordingly no display of the registration mark in two rows will be allowed if the application is accepted.

7. 申請人如中籤而其申請的自訂車輛登記號碼組合符合有關基本組合規定的話,運輸署將要求他繳交5,000元按金,在接獲按金後,運輸署署長會根據法例規定,決定是否接納有關申請及安排拍賣。如其申請不獲接納,或申請獲批但申請人未能於拍賣會投得該自訂車輛登記號碼,運輸署將會向申請人退回按金。有關詳情,請參閱《道路交通(車輛登記及領牌)規例》及申請須知。

For applications which are selected by lot and comply with the relevant basic combination requirements, the applicants will be required to pay a deposit of \$5,000. Upon receipt of the deposit, the Commissioner for Transport will determine, in accordance with the statutory provisions, whether to accept the application and arrange auction of the personalized vehicle registration mark. The deposit will be refunded to the applicant if the application is rejected, or if the application is accepted but the applicant is unsuccessful in bidding the mark in the auction. For details, please refer to the Road Traffic (Registration and Licensing of Vehicles) Regulations and the Guidance Notes.

8. 按照《道路交通(車輛登記及領牌)規例》(第374E章)第12B條的 規定,署長在接獲申請後,即不得受理任何要求撤回該申請的請求。 就此,運輸署不會退還因申請所繳付的按金。

In accordance with Regulation 12B of the Road Traffic (Registration and Licensing of Vehicles) Regulations, Cap. 374E, the Commissioner shall not entertain any request to withdraw an application. In this regard, the Transport Department will not refund the deposit paid for the application.

The processing of applications for personalized vehicle registration marks involves several stages and is taken by batches. As a general reference, it would normally take around 15-18 months or more for an application to complete the process and have the approved mark from the deadline for applications of each exercise to be put up for auction. The processing time would be even longer if the applied mark requires further examination during the vetting stage.
